## 2023-2032 25C Qualifying Models\*

January 1, 2023 – December 31, 2032

<b>Limit</b>	30% of installed cost up to capped amount
<b>Total Claim</b>	Tax credit parameters indicate a \$2,000 tax credit for heat pumps. In addition, there is a \$1,200 aggregate yearly tax credit maximum for all building envelope components, home energy audits, and energy property, for a total maximum up to \$3,200.
<b>Equipment Criteria</b>	Highest CEE efficiency tier (not including any advanced tier) when placed into service. NOTE: Criteria not static and will change if CEE amends criteria.
